A NYC ACP5 Inspection is required by The NYC Dept of Environmental Protection (DEP) prior to the start of any renovation or demolition project. The ACP5 Inspection ensures that no asbestos will be disturbed during the construction or renovation process.

Building Demolition

An asbestos survey or inspection is required prior to any building/structure demolition, remodeling, renovation or repair. All suspect material must be sampled to ensure that no asbestos will be disturbed during the demolition process.

Is that pipe in your basement wrapped in asbestos? Do your floor tiles contain asbestos?

MOLD

Please be AWARE!

As of January 1, 2016 inspectors and remediators must be licensed by New York State to perform any type of mold inspection or remediation.

Mold Inspections

If you have concerns about mold or air-quality issues Accredited is equipped to provide you with a variety of tests to determine if a mold problem exists. Air-quality testing, direct sampling and other analytical methods can determine if there is a reason for concern (fungal contamination), and if there is, the extent of the problem.

If remediation is necessary Accredited will attempt to isolate the source of the moisture creating the mold issue. Specific recommendations will be developed to correct the problem and a remediation plan will be provided to the mold-abatement contractor to follow, according to NYS Guidelines.

Mold Remediation

A small water leak or even excess humidity is all that's required for mold to proliferate in as little as 24–48 hours. Mold can produce allergens and irritants and potentially can cause severe respiratory problems. If you can see mold growing, your top priority is to have it properly removed and safely disposed of.
