• NY Mold Assessor

The NY Mold Assessor Course is required for professionals who own or operate a sole proprietorship mold assessment company OR perform mold assessments OR write mold remediation plans.

The New York State Labor Law requires 32 hours of training in mold, moisture, respiratory protection, protocol writing, post-remediation clearance and a proctored examination. After completion of the course an application is filed with New York State for licensure.

This 4 day course covers all New York State requirements for mold licensure such as:

- Work place hazards, PPE, respirators
- Biological sampling
- State of the art work practices and new technology
- Best practices for documentation, report writing, field notes, chains of custody
- Building construction, building sciences, moisture control, water intrusion events
- Technical and legal considerations
- HVAC systems basics, inspection & assessment of HVAC
- Work practices for removing, cleaning & treating mold
- EPA, NYCDOH, OSHA, IICRC S520
- Case studies
- Hands on training, test & certificate of completion

• NY Mold Remediation Contractor

The NY Mold Remediation Contractor Course is required for professionals who own or operate a mold remediation company OR will prepare mold remediation plans OR if you supervise mold remediation workers.

The New York State Labor Law requires 24 hours of training in mold, moisture, respiratory protection, protocol writing, post-remediation clearance and a proctored examination. After completion of the course an application is filed with New York State for licensure.

This 3 day course covers all New York State requirements for mold licensure such as:

- Work place hazards, PPE, respirators
- State of the art work practices and new technology

- HVAC systems basics, inspection & assessment of HVAC
- Technical and legal considerations
- Overview of how mold remediation projects are conducted

• NY Mold Abatement Worker

The NY Mold Abatement Worker Course is required for workers that perform mold abatement work only.

The New York State Labor Law requires 16 hours of training in mold, moisture, respiratory protection, hazard communication, workplace safety and a proctored examination. After completion of the course an application is filed with New York State for licensure.

This 2 day course covers all New York State requirements for mold licensure such as:

- Indoor air pollution and sick building syndrome
- Potential Health Effects
- Hazard Communication
- Work place hazards, PPE, respirators, confined spaces, lock out/tag out
- Overview of how mold remediation projects are conducted
- Work practices for removing, cleaning and treating mold
- State of the art technology
- Hands on work area prep
- Test & certificate of completion

As of January 1, 2016 New York State has placed new restrictions on Home Inspectors by instituting the NYS Mold Licensing Law - Article 32 of the New York State Labor Law. If you are not licensed by NYS as a “mold assessor” (inspector) you should not be commenting about mold in your Home Inspection report or be subject to steep fines.

Excerpt from New York State DOL website:

Persons who conduct home inspections as part of potential real estate transactions must also be licensed as a “Mold Assessor” if their inspections/reports include an assessment of mold conditions in the home or property in question.
